Supervisor Hansen said he spoke with a few other County Supervisors over the phone regarding Data Centers. Supervisor Mosinski has an upcoming Region XII meeting and ACED meeting. The generator control panel quotes are still not in yet. Motion- Hansen Second- Mosinski to approve voting for the recommended three individuals for the IMWCA Board of Trustees. Vote-all in favor. Budget Amendment #1 Appropriation/Authorize Increase in Operating Transfers Accordingly

WHEREAS, on this day, the Board of Supervisors of Audubon County amended the current county budget for fiscal year ending June 30, 2027, and had published the amendment according to the law, and

WHEREAS, it is now desired to amend the appropriations for the departments,

NOW, THEREFORE, BE IT RESOLVED, by the Audubon County Board of Supervisors that the appropriations be amended effective August 18, 2026 as follows:

Meeting adjourned at 10:25 am.
